Contract Agreement for Vendor at the Odessa Fair

This agreement ("Agreement") is made effective as of April 25, 2024, between Ken Bethune, located herein after referred to as the "Vendor", and Odessa Agricultural Society, located at 231 Main St. Odessa, ON, hereinafter referred to as the "Society".

1. Term of Agreement:

The Vendor shall set up their space at the Odessa Agricultural Society fair located at 231 Main St., Odessa from Thursday, August 15, 2024, through Sunday, August 17, 2024.

2. Setup:

The Vendor shall be responsible for setting up their space in a location designated by the Society within the fairgrounds. Setup shall commence on Friday, August 16 11:00-3:30 pm, 2024.

3. Operation Hours:

The market space shall operate during the fair's operational hours from Friday, August 16, 2024, through Sunday, August 18, 2024.

4. Fees and Charges:

a. The Vendor shall pay a \$40 for each 10'x 10' space. An additional \$10 for electrical hookup.

5. Compliance with Regulations:

The Vendor shall comply with all applicable laws, regulations, and ordinances governing the operation of a vendor space, including obtaining any necessary permits or licenses.

6. Insurance:

The Vendor shall provide a copy of the Certificate of Insurance with a minimum \$5,000,000 liability coverage naming Odessa Agricultural Society as an Additional Insured.

7. Indemnification:

The Vendor shall indemnify and hold harmless the Society, its officers, directors, employees, and agents from and against any and all claims, damages, losses, liabilities, and expenses arising out of or resulting from the Vendor's operation of the lemonade stand at the fair.

8. Termination:

Either party may terminate this Agreement upon written notice to the other party if the other party materially breaches any provision of this Agreement and fails to cure such breach within 1 day after receiving written notice thereof.

9. Entire Agreement:

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, understandings, negotiations, and discussions, whether oral or written, between the parties.

10. Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario.

IN WITNESS WHEREOF, the parties have executed this Agreement as of the date first above written.
